## SO2 Corps

Greetings to all past and present corps members. 2006 is ending pretty much the way it started: very quickly. Members of the corps are serving in a number of areas of operations around the globe as well as contributing to additional commitments such as AACAP. Those not committed to these tasks may well be on restitution, or lead up training to deploy. It is evident throughout these times of extreme tempo, the spirit and camaraderie of our Crafties is not daunted. This was especially epitomised by the lads that decided the HMAS Kanimbla would make a fine FRT wagon in Timor.

I will also take this opportunity to thank those members of the Corps that regularly take the time to assist me in HOC tasks by offering comment and opinion across a wide gambit of issues. Whilst feedback is often slow, rest assured that your input is being elevated to the appropriate level. In time this should see some of the Corps long standing issues resolved, or at least acknowledged, by the higher echelons. Your continued input is appreciated given the present tempo of operations.

### **RAEME Corps Seminar**

This year the seminar theme is '*MMM in Support of ADF Operations*' and will focus on the employment of MMM in the maintenance of operational availability, in particular the user profiles required by RAEME Officers and soldiers of all ranks. It is requested that you make every effort to attend to offer your opinion towards what will eventually be the Corps' position on the way ahead for Maintenance Management. DMO and Project staff are encouraged to be actively involved in this quorum to ensure that a 'top – down' approach is tabled. The seminar this year will be conducted 19 - 20 Oct, with the Corps Committee meeting and all ranks BBQ on the 18<sup>th</sup>. The National ARA and AR Craftsman of the year will also be presented during the seminar.

### **Maintenance Manager Pre Appointment Seminar**

The Land Material Maintenance Support (LMMSR) review being conducted by BRIG Barnett identified that a number of RAEME ASM believed there was a knowledge deficiency with regard to implementation strategies in corporate governance procedures (TRF), MMM training in general and overall situational awareness required of first appointment ASMs. This has led to the implementation of a DTR-A sponsored pre appointment seminar for most first appointment ASM and other select RAEME SNCO filling senior maintenance manager positions. The seminar will be run 16-18<sup>th</sup> Oct, prior to the Corps seminar. DTR-A will fund selected candidates for travel and incidentals for the period 15 – 21 Oct 06. It is requested that all candidates identified make themselves available for this initiative.

### **Clerk Production Update**

SCMA advise the current asset / liability for OPSUP PC is 44 / 61, a delta of 17 positions vacant. Again, it is suggested that Workshop commanders and ASM check unit SED to ensure that OPSUP posted into workshop support positions are not defaulting to the QM/RQ. It is anticipated that a OPSUP PC workbook will be available by the Corps Seminar to allow Workshop Commanders / ASM to provide a mentoring role to OPSUP posted into your sub – unit / TSP.

### **Work Value Units**

The WVU calculator project being conducted by DSTO is progressing, albeit slowly. The necessity to use MMM as the base data input has caused some delay in clearly, and accurately, articulating ART conducted by our tradesmen. This is due to incomplete, or incorrect, data entry in the required fields on MMM. Eg: line/grade of repair or trade code conducting repairs. From a scientific analysis view, missing data sets cause that particular repair unusable as a reference.

To assist in the interpretation of missing data sets, a number of SME have been working closely with DSTO to provide the 'reality check' to what may be simple data entry finger faults. This aspect of the project has highlighted the criticality of accurate and complete data being loaded onto MMM. This applies across all levels in the maintenance management process, from Project and Fleet Managers, to the Craftsman on the floor.

## ECN v SED

The DFRT pay case for the nine RAEME Ground Trades is progressing well with the Trade Managers putting in the hard yards on behalf of the Corps. You may be aware that one of the potential outcomes of the case is the redesignating of ECN across the trades. ECN 226 may have descriptors from 226-1 up to 226-19, depending on whether soldier is ARA or AR, and specialist equipments they are qualified to maintain. This outcome will require the actual position descriptor on individual SED to be amended to allow multiple ECN to be employed in that position. ie: WO2 Recovery Mechanic may be ECN 226-19 (ARA) or 226-18 (AR). This amendment will allow PMKeyS to pay members filling positions such as CFTS etc.

## MMM

A number of pilot MMM courses have been conducted under contract at DMST. These range from the basic Work Order Admin, through to the ADFLM course. RAEME personnel from Training Development Group attended these courses and feedback they provided was very positive. With some minor alterations, these courses may, in future, be linked to the Subject 4 RAEME suite of courses.

Liaison visits by the HOC team have identified confusion regarding when and where FLMS is used. The HOC, Brigadier McGahey, has the expectation that FLMS is used on a day by day basis within the unit to allow familiarity and confidence in the system to be raised. If units require more FLMS laptops or associated CES, demands should be made through the formations to LHQ for on forwarding to DMST. The HOC is committed to providing the required resources to allow units to conduct best maintenance practice.

Again, I ask that commanders at all levels pass the Corps newsletter to **all** of our soldiers.

### **TRADE MATTERS**

## **Defence Force Remuneration Tribunal (DFRT) Submission**

As I said earlier in the year 2006 is a very busy year for the EME Cell at Development Group, ALTC. We have a number of high profile things on the go at the moment, probably the highest profile being the RAEME Ground Trades Defence Force Remuneration Tribunal (DFRT) Submission that we are putting forward on 6/7 December in Canberra. However, before we do that we have the DFRT Site Visit scheduled for 24/25 October in Darwin. The site visit is our opportunity to show off the RAEME ground trades to the DFRT and highlight some of the issues we are putting forward in our submission.

I'm not going to go into any detail here about the submission apart from saying that we are confident of a good result for the RAEME ground trades and hope it results in a restructure that allows us to identify the differences between ARA and Army Reserve members. When RAEME last went to the DFRT in 1994 ARA and Army Reserve were taken up as one package as the Army had the 'One Army' principle where we were not allowed to distinguish between ARA and Army Reserve. What did this mean? Well Army Reserve members were expected to complete the same training as ARA members. This did not suit RAEME as most of our courses are longer than the two weeks that Army Reserve members can dedicate to these courses. It has now been acknowledged that this doesn't work and we need to have different courses that allow Army Reserve members to be trained in two week periods. It has been accepted that these members will not be trained to the same level as ARA members. So if we have two different skills sets, how do we identify the differences between ARA and Army Reserve? The answer will be through the new trade structures that we are putting forward where the members ECN/trade name will indicate the training that members have undertaken. I will not go into too much detail at the moment, but I will expand during my next RAEME Craftsman article.

## **Trade Reviews**

At the same time that we are doing the DFRT submission, we are also conducting Trade Reviews on Technician Electrical, Fitter Armament and Artificer Ground trades. The Trade Reviews are done in order to assess whether these trades are meeting Army's capability requirements and whether the training we are delivering at ALTC is allowing these trades to meet Army's capability requirements. If you are one of these trades or a Fitter Armament based Artificer Mechanical or Technician Electrical based Artificer Electronic then you should have received information about the surveys in your Lotus Notes. It is important that you complete these surveys because they will be used to write the trade reports for these trades. We will make decisions on where these trades go in the future. ## **Refrigerant Gases**

For those members concerned about the licensing requirements for refrigerant gases and about the fact that Army has now gone past the original 31 Jul 06 deadline, you need not worry. We have been granted a further extension. Below is an extract of an email forwarded to Army by the Department of Environment and Heritage (DEH) that extends our waiver.

*Ozone Protection and Synthetic Greenhouse Gas Management Regulations 1995*

*Refrigeration and Air Conditioning and Fire Protection Licensing*

*This email is to confirm that the Department of the Environment and Heritage (DEH) is continuing to negotiate with the Department of Defence on a Memorandum of Understanding to implement the Refrigeration and Air Conditioning and Fire Protection licensing systems. Whilst negotiations are ongoing, DEH will take this into account when considering if any action is required under regulations 111, 112, 302 and 303 of the Ozone Protection and Synthetic Greenhouse Gas Management Regulations 1995.*

## **Army Reserve Conversion and Subject Four Courses**

As the WO1 Trade Manager for RAEME Ground Trades I am well aware of the current issues out there in Army Reserve Units relating to the lack of Army Reserve conversion courses for Vehicle Mechanics and Subject Four courses. I am very pleased to say that the Army School of Electrical and Mechanical Engineering is currently scheduling these courses and they should commence in 2007. As these are all new courses, the lesson plans, training packages and assessment packages all need to be

developed prior to delivery and that is the main reason for the delay. So for those frustrated members out there waiting for these courses, please hang in there.

## MESSAGE FROM CA RAEME, DOCM-A

Greetings from DOCM-A.

The 2007 Posting Planning Cycle is well advanced with the issue of the first round of posting orders issued on 1 Jul. The DOCM-A selections process had to be revised and adjusted to meet a constantly changing liability with impacts felt from changes in the authorised establishment of HQ JOC, 2 Div (all units), LHQ, ADFWC, LWDC, SOD, DSTO and CSIG. Despite the best efforts of DOCM-A many officers had to be briefed on a number of alternate postings, resulting in considerable frustration for those officers and their families.

For CAPT and MAJ (our critical ranks) the current asset liability gap is currently 488 and there are 187 CAPT/ MAJ on CFTS (and 15 x WO1) to close the gap. Interestingly CAPT retention has exceeded APEP 07 forecasts (just) and MAJ retention has matched forecasts. A number of units are currently grappling with vacancies driven by the 108 officers currently on individual operational deployments (of which 96 x LTCOL - LT are without backfill).

DOCM has finished the moratorium period and work is advancing on the second round of officer posting orders, which will be issued on 15 Sep 06. From 16 Sep 06 the regional lock occurs, where there will be no changes to officer posted locations, however there may be movement between units that are in the same location. The regional lock in is a process that allows families to plan appropriately for 2007.

As a reminder, the time is fast approaching for the submission of PAR's. PAR's for Majors being considered for ACSC are due to DOCM by 1 Sept 06. It is important that the PAR's are received by DOCM at the correct time as these form the one of the critical elements of the PAC submissions. One of the other key aspects of an officer's appearance at the PAC is your AIRN status. The advice from DOCM is that you should now attempt to clear your AIRN requirements out until the end of 2006 so that it enhances your prospects of a PAC clearance.

One of the key sources of frustration of officers is the completion of courses. The schedule of courses until the end of 2008 is available on PMKeys. Units are encouraged to nominate their officers for these courses to minimise the impact of courses on unit activities. RAEME is currently experiencing a bottleneck in available positions on the LOBC. At the moment there is approximately a six-month wait for the LOBC, which is causing a great deal of concern and frustration across a number of levels. ALTC, DOCM and HA TC-A have all been working hard to find a solution to this important problem and your patience has been appreciated.
